PRIVACY POLICY

This Privacy Statement applies to information collected by Monty Global Payments USA, LLC (MGP) in connection with the Services.

MGP takes your privacy very seriously. This Privacy Policy applies to MGP websites (for purposes of this Privacy Policy, "websites" includes www.clicktransfer.us, our mobile websites, and our mobile applications) and the services associated with it ("MGP" or "the Service").

This Privacy Policy applies to information related and retrieved in connection to the Service.

Terms used but not defined in this Privacy Policy have the meanings assigned to them in our User Agreement.

MGP is committed to protecting our customers' privacy and security. This Privacy Policy explains what personal information we collect about you, with whom we share it, and how you (the user of the Service) can direct us not to share certain information with certain parties. "Personal Information" refers to information that can be used to identify an individual.

You should read this Privacy Policy in its entirety. Certain sections may apply differently to residents of different jurisdictions.

1. Description

The types of personal information we collect and share depend on the product or service you have with us. We may collect the following information about the Sender and Beneficiary, which may include non-public Personal Information:

- government identification numbers, such as driver's license, state identification, passport, visa, Social Security or tax identification number;
- name, address, email address, mobile and home telephone number, age, date of birth, gender, citizenship, occupation and marital status;
- account balances and transaction history;
- credit, debit, bank account and payment history information;
- computer and mobile device information, such as the domain and host you use to access the Internet; your computer's IP address; mobile device geolocation, number and other information from and about your device (such as device properties, settings, applications, stored information and usage) and carrier; the browser and operating system software you use; websites you have visited or later visit, social profile and network information; the date and time you access our website, the internet address used to link to our website when you visit us, and cookie information.

You consent to our collection, storage and transfer of information by computers or storage devices in the United States and elsewhere.

2. Reason for Collecting your Information

- a. To process your Transactions;
- b. To verify your identity;
- c. To collect payment for your use of the Service;
- d. To allow our partners to fulfill their promotional obligations to you;
- e. To troubleshoot problems with the Service;
- f. To comply with applicable laws, regulations, and rules, such as those relating to "know-your-customer" and anti-money laundering requirements;
- g. To detect and prevent fraud and other illegal uses of the Service; and
- h. To send you marketing notices, service updates, and promotional offers.

3. Method for Collecting your Information

We collect your personal information, for example, when you:

- a. send or receive money, complete a payment or use or request other products or services from us or other financial companies;

- c. use or visit our or other online sites (for example, to complete a transaction, manage your accounts, or provide your choices);

- e. use our mobile app or internet sites, such as www.clicktransfer.us.

We also collect and corroborate information about you from a variety of sources, including without limitation, computer systems and mobile devices; third party sources such as our business clients, government agencies, advertising agencies and networks, social media operators and networks, and other suppliers of information; and consumer reporting agencies.

We may collect, track and combine information across devices, platforms and transaction channels.

4. Disclaimer: Software and Analytics Assessing your Information and Use of the Service

As is true of most websites, we gather certain information automatically and store it in log files. This information may include your internet protocol (IP) address, browser type, internet service provider (ISP), referring/exit pages, operating system, date/time stamp, and/or clickstream data. From time to time, we may combine this automatically collected data to other information we collect about you for reasons such as analysis, security, content generation or marketing.

We may use the analytics tool in order to develop and analyze use of the Service. Analytics companies may access anonymous data (such as your identifier for advertising or device identifier) to help us understand how the Service is used. They use this data on our behalf and do not use this data for their own purposes except in aggregate form; they do not share data as to any individual user except in limited circumstances. 5. Use of Information

MGP does not sell or rent the information we collect to third parties for their promotional purpose unless we receive your permission to do so.

Nevertheless, we may share information about the Sender and the Beneficiary (including non-public Personal Information) in the following manners:

Disclosures not subject to an opt-out choice include: disclosures necessary to effect, manage or execute a transaction you requested; disclosures to our authorized vendors, or service providers; disclosures permitted or required by law or disclosures to prevent fraud or other illegal activities.

Without obtaining your consent, MGP has the right to share your personal information for the following reasons:

- For our everyday business purposes, such as to process your transactions; manage our consumer relationships; provide requested products and services; maintain your account(s); respond to court orders and legal investigations; report to credit bureaus; gather information about website access, usage and performance; enhance your consumer experience; validate your creditworthiness or your identity; in connection with a merger, acquisition or sale of the company or any of its assets; make risk decisions; detect and prevent fraud and other illegal activity; or as otherwise permitted or required by law.
- For our marketing purposes such as to offer our products and services to you or notify you about future events and promotions.
- For our affiliates' everyday business purposes such as information about your transactions and experiences.
- In the event of the sale, acquisition or merger of some or all of our assets, Personal Information about you, your Recipient or your Beneficiary might be a part of the transferred assets. We shall notify you in the event of such an occurrence and inform you of any choices you may have regarding your Personal Information, by placing a notice on our websites;
- Law enforcement, government officials or other third parties, but only in connection with a formal request, subpoena, court order, or similar legal procedure; or
- When we believe in good faith that disclosure is necessary to comply with the law, prevent physical harm or financial loss, report suspected illegal activity, or to investigate violations.

After obtaining your consent, MGP has the right to share your personal information for the following reasons:

- For our affiliates' everyday business purposes such as information about your creditworthiness.
- For our affiliates to market to you.
- For non-affiliates to market to you.

If you prefer that we limit sharing with affiliates or nonaffiliated third parties as described above, you may opt-out of those disclosures through any of the following methods:

6. Access to your Information

7. Choices you can make about our use of your information
